

SUMMARY ANNUAL REPORT FOR CSM CORPORATION WRAP PLAN

This is a summary of the annual report of the CSM Corporation Wrap Plan, a health, life insurance, dental, vision, temporary disability, long-term disability and death benefits plan (Employer Identification Number 41-1320338, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

CSM Corporation has committed itself to pay certain Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with EYEMED VISION CARE ON BEHALF OF COMBINED INSURANCE COMPANY OF AMERICA, UNUM LIFE INSURANCE COMPANY OF AMERICA, Unum Life Insurance Company of North America, Provident Life and Accident Insurance Company and Unum Life Insurance Company of America to pay certain Vision, Life insurance, Long-term disability, AD&D, Voluntary AD&D, Disability, Indemnity Contract, Critical illness and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$212,101.

Paperwork Reduction Act Statement
